

# Reporting Dates Calendar

## Full and Half Year Results Announcements and Annual Reports

### NZX Listing Rule 3.5.1 and 3.6.1.

Pursuant to the above Listing Rules, full and half year results announcements are required to be provided to NZX for release to the market, no later than 60 days after the relevant balance date. Annual reports are required to be provided to NZX for release to the market, no later than 3 months after the relevant balance date.

Where a due date falls on a weekend or another non NZX trading day, the relevant results or report should be provided to NZX by close of business on the immediately following Business Day.
